### Plympton Road Proposed Bike Hangar

This document outlines our proposals for the introduction of a Bike Hangar on Plympton Road. Please read the information in this document, then complete, and return the enclosed questionnaire - **postage is free**. #### **Why are we proposing this change?**

Brent Council aims to improve facilities for cyclists in the borough and promote active and sustainable travel. In line with the vision set out in our Cycle Strategy 2016-2021, the Council is encouraging more residents to take up cycling, to enjoy the health benefits that this brings and to help reduce traffic congestion and improve air quality in the borough.

The Council has received several requests from residents in the area to provide secure cycle parking in streets where they do not have access to private outdoor space. Bikes can block hallways and staircases in some properties, and those left on street can be a target for cycle theft.

Through its cycle parking programme, the Council propose to install bike hangars in areas where there is a high demand from local residents for this facility.

#### **What is being proposed?**



We are proposing to introduce a Bike Hangar on Plympton Road as shown on the enclosed plan. The proposed Bike Hangar would be located around the corner of 81 Torbay Road, next to a blank wall, on a parking bay.

The hangar, which has the capacity to store six bicycles, will be rented to users for an annual fee.

Please see to the left a visual of the bike hangar that we are proposing to install on Plympton Road.

#### **What will happen next?**



# Proposed Bike Hangar location on Plympton Road




