

# LONDON BOROUGH OF BRENT THE BRENT (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. \*) ORDER 202\*

- NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent propose to make the above mentioned Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part I of Schedule 5 to the Local Government Act 1985.
- 2. The general effect of the 'Waiting and Loading Restriction' Order would be to further amend the Brent (Waiting and Loading Restriction) Order 1979, so that:-
  - (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited at any time in the lengths of streets specified in Schedule 1 to this Notice and between 8 a.m. to 6.30 p.m. on Mondays to Fridays in the lengths of streets specified in Schedule 2 to this Notice;
  - (b) waiting by vehicles (for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited at any time in the lengths of street specified in Schedule 3 to this Notice:
  - (c) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 40 minutes in the same place would be prohibited in the lengths of street specified in Schedules 1 and 2 inclusive to this Notice:
  - (d) the sale or offer for sale of goods from a vehicle would be prohibited (except on Sundays) in the lengths of streets specified in Schedules 1 to 3 inclusive to this Notice, unless there is in force a valid licence issued by the Brent Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
  - (e) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising would be prohibited in the lengths of streets specified in Schedules 1 to 3 inclusive to this Notice;
  - (f) any existing prohibition on the waiting by vehicles, the sale or offer for sale of goods from a vehicle or the use of any vehicle or animal or the wearing of fancy dress or other costume wholly or mainly for the purpose of advertising in the lengths of streets specified in Schedules 1 to 3 inclusive to this Notice would be revoked:
  - (g) minor drafting amendments are made to the waiting restrictions in Nathans Road to conform to the current on site layout.
- 3. The prohibitions referred to in sub-paragraphs 2(a) to (c) inclusive above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Blue Badge" would apply.
- A copy of the proposed Order, of the relevant Order of 1979 (and of any Orders which have amended that Order), of the Council's statement of reasons for proposing to make the Order and of maps which indicate each length of road to which the Order relates can be inspected during normal office hours on Mondays to Fridays inclusive until the end of a period of 6 weeks from the date on which the Order is made or the Council decides not to make the Order at Brent Customer Services, Brent Civic Centre, Engineers Way, Wembley, Middlesex, HA9 0FJ. Please note:- that we are unable to provide access to the council offices while coronavirus (COVID 19) social distancing measures are in place and the documents have been made available for inspection https://consultation.brent.gov.uk/highways-and-infrastructure/traffic-order-to-02-270/np.

## **SCHEDULE 1**

# Waiting restrictions (At any time)

#### Barn Hill:-

- (a) the north-west side, between 10 metres north-west of The Crossway and 23.5 metres north-west of The Crossway;
- (b) the north-east side, between the north-eastern boundary of No. 46B Barn Hill and the common boundary of Nos. 42 and 44 Barn Hill;
- (c) the north-east side, between the common boundary of Nos. 50 and 52 Barn Hill and the common boundary of Nos. 54 and 56 Barn Hill;

#### **Birchwood Court:-**

- (a) the south-east side, between 10 metres south-west of Limesdale Gardens and its south-western extremity;
- (b) the north-west side
  - (i) between 10 metres south-west of Limesdale Gardens and 41 metres southwest of Limesdale Gardens:
  - (ii) between the common boundary of Nos. 16 and 18 Birchwood Court and its south-western extremity;

**Beverley Gardens**, the south-east side, between 4.3 metres south-west of The unnamed road fronting the side of No. 98 Uxendon Hill and its junction with Uxendon Hill;

**Brondesbury Park**, the north-east side, between 4.6 metres south-east of the common boundary of Nos. 73 and 75 Brondesbury Park and 15.2 metres north-west of that common boundary.

**Union Road**, the south-east side, between 3 metres south-west of the south-western wall of No. 22 Union Road and 3 metres north-east of the party wall of Nos. 19 and 20 Union Road;

The unnamed road fronting the side of No. 98 Uxendon Hill, between Uxendon Hill and 11.2 metres south-east of Uxendon Hill.

#### **SCHEDULE 2**

#### Waiting restrictions (8 a.m. to 6.30 p.m. on Mondays to Fridays)

## Mount Pleasant:-

- (a) the north-east side, between the party wall of Nos. 76 and 78 Mount Pleasant and the party wall of Nos. 102 and 104 Mount Pleasant;
- (b) .the north-west side, between the party wall of Nos. 160 and 162 Mount Pleasant and 4.2 metres south-west of the party wall of Nos. 194 and 16 Mount Pleasant.

#### **SCHEDULE 3**

# Loading restrictions (At any time)

Barn Hill, the south-east side, between 7.5 metres north-east of the common boundary of Nos. 2 and 4 Barn Hill and 5.5 metres south-west of the party wall of Nos. 10 and 12 Barn Hill; Woodside Avenue, the south-west side, between Woodside End and the party wall of Nos. 88 and 90 Woodside Avenue;

**Woodside End**, the north-west side, between Woodside Avenue and its south-western extremity.
